

**Our Village Road maintenance program** will begin in early October in order to avoid traffic conflicts with the Apple Fest and Prairie State Half Marathon events. The resurfacing project will impact Creekside Drive, Tribal Court, Arrowhead Court, Robert Parker Coffin Road (from Archer Parking Lot to IL Route 83), Robert Parker Coffin Road (from the covered bridge to IL Route 53), Archer Road, Long Grove Road (at the intersection of IL Route 53), Three Lakes Drive, and Three Lakes Court (see map). Expected completion of the project is November 3, 2023.



**The Osage Road Drainage Improvement Project** includes installation of a 24" diameter storm sewer pipe from 7057-7051 Osage Road. This project is partially funded by a Storm Water Infrastructure Grant from the Lake County Stormwater Management Commission. Village Engineer Geoff Perry added, "The project has been designed to reduce flooding in the rear



yards of the properties on the northerly side of Osage Road, which has been a long-standing issue. We anticipate the work taking about 2-weeks; however, the start date is to be determined, based on material delivery and utility resolution."

### Planning Fall Repairs? Know When to get a Building Permit



Your home or business properties are among the largest investments of your life. When it comes time to make improvements, structural changes or additions, a building permit helps you by securing expertise in municipal code standards enforced by licensed professionals. Securing a building permit can also prevent potential obstacles down the road when you are ready to sell your property.

It is important to note that a permit is also required for demolition, lawn irrigation systems, water heaters, electrical upgrades, generators and more. A complete listing of projects requiring permits, and our fee schedule is available on our website longgroveil.gov/building

## **Exploring New Village Hall Options**

Earlier this year the Village Board of Trustees engaged Wold Architects of Palatine to present options for expanding the existing Village Hall space or constructing a new facility. Wold refers to this work as the "programing phase," where the firm has discussions with the client to identify what is needed, and then embarks to schematic design phase that illustrates the guiding principles discussed in previous meetings.

Matt Bickel of Wold Architects said, "Our process is based on collaboration. It's important not to design in a vacuum and present what we think works for you. It's critical we work in tandem to understand the values and priorities. Our mission is to create a unique structure that respects the history of Long Grove while incorporating modern, energy efficient design that will stand the test of time."



The architects are also exploring floor plan options that offer more flexible space for meetings / gatherings with a reconfigured working environment that encourages collaboration to retain and attract future talent. Village leadership will be meeting with Wold team members during September to review their progress

and determine the next milestones for the project. Additional updates will be on our website, social media channels and in our next issue of this newsletter in December.

If you have been inside the Museum, you'll know it is quite the experience. Congratulations Arlene on this wonderful accomplishment. Please stop in if you haven't already.

John Bosher and Chris Charles, who filmed *Christmas with Felicity* in our Village, will soon release their second film featuring Long Grove, "*Reporting for Christmas*." They just shared plans for a third movie with sequences to be filmed here this Fall. More details will be coming as timing and logistics are worked out. It is nice to see our Village showcased in these films. Thank you, John and Chris, for featuring Long Grove and partnering with our downtown merchants.

Back to municipal operations... After 9 years we are approximately 77% complete on our 15-year road paving plan – without levying a property tax. This was a contentious issue in 2014 when over 83% of our residents voted against implementing the Village's first property tax to provide funding to repave our roads. Finally, there is still much on the docket this year including hiring a new Village Manager, a proposed addition to our Village Hall utilizing the American Rescue Plan Funds we received and connecting our downtown potable water system to Lake Michigan via an expected \$2.3 million in federal funding. As of this writing we are awaiting word from **Congresswoman Jan Schakowsky's** office. Her staff submitted this infrastructure project for the appropriations bill in the upcoming fiscal year.

We look forward to making some great progress in the Village this Fall. # **RPC Bridge Still Going Strong at 117**

Anyone familiar with the Village of Long Grove knows that we have a BRIDGE. In 2022, we officially named it the Robert Parker Coffin Bridge. In the mid-1850's the bridge was a wooden

structure designed to transport residents across Buffalo Creek. In the early 1900's a new 41 foot single-lane metal truss bridge was built by the Joliet Bridge and Iron Company.

In 1972, the Long Grove Village Board voted to have a cover built for the bridge to protect it from the elements and to prevent heavy

trucks from crossing it. They chose a design by then current Village President,

Robert Parker Coffin, a local architect, builder and engineer to design and construct the decorative cover. It served its purpose until 2018.

With the efforts of the Long Grove Historical Society and the Historic Downtown Long Grove Business Association (HDLGBA), an application for the National Register of Historic places was successfully accomplished in 2018. Very shortly thereafter the bridge was struck and the cover totally destroyed.

The Village had been considering




replacing the bridge when it was struck and the cover was destroyed. Many possibilities were considered but in 2019 the Village decided to proceed with a full reconstruction at a cost of \$1,100,000. It

> was possible to do so through the collaboration of the State of Illinois, (\$250,000), Long Grove Historical Society, (\$54,000), insurance, (\$204,000) with the Village paying the remainder.

True to Mr. Coffin's original design, the bridge was reconstructed. The most important change to the bridge cannot be seen unless you are on the bridge. The Village added a steel reinforcement structure inside the bridge covering to protect it from

serious damage. The new structure has already proven its worth, having protected the cover which has been hit numerous times resulting in minimal damage. We hope drivers note all cautioning signage leading to the Bridge.



One other unexpected result of the bridge replacement was the substitution of the old limestone block abutments with new colored concrete finished to emulate the look of the original abutments. The old abutments are now located in the new Buffalo Creek Park being built by the HDLGBA.

Art Osten, Jr. was brought aboard to serve as Interim Village Manager, as an executive search is underway to secure a permanent administrator. Mr. Osten has extensive government experience, spending 14-years as the administrator of the Village of Fox River Grove. In recent times Art has also served as interim manager at Indian Head Park, Oak Brook and Genoa.

Dana McCarthy joined the Village team in July as our new Assistant Village Manager. Prior to joining us, he worked for the Winthrop Harbor School District #1, and served in leadership at Feed My Starving Children. Dana was elected Trustee at the Village of Winthrop Harbor in 2013, and continues to serve in that role.

### Open Burn Requirements-Protecting Our Environment and Your Property

There are many benefits to an open or prescribed burn. Removing old vegetation, dead/downed trees and twigs makes room for new growth, while reducing the possibility of wildfires. The Illinois Environmental Protection Agency (IEPA) requires the Village of Long Grove to apply for an annual permit and submit a list of properties to be included in planned burns.

For faster processing residents planning open burns should complete the webform which can be found on our website; longgroveil.gov/burning. Addresses are added to the open burn permit list and submitted as an application to the State. Once the State approves the application, the applicant will be notified via email. Properties that are approved must then contact the Long Grove Fire Protection District, (847) 634-3143, or Countryside Fire Protection District, (847) 367-5511, to obtain a permit to perform an open burn.

Working together we can help maintain a natural balance and keep our Village safe.

Business owners should provide proof that their operation


