Both of these individuals will be greatly missed, but their contributions will live on.

I'm appreciative of the Historic Downtown Business Association and the vibrancy that business owners continue to bring to our downtown. Their creativity never ceases to amaze, and they have thrived through the pandemic. I'm grateful we have so many other businesses in our community beyond the downtown providing goods and services to us all. I'm thankful for the sales tax receipts that all our Long Grove businesses provide enabling our Village to operate without levying a real estate tax.

I want to thank the Long Grove and Countryside Fire Protection Districts and the Lake County Sheriff's Police for the exceptional service they provide in keeping us safe. I'm thankful for the talented teachers and staff that are educating our children in the school districts that serve Long Grove. I'm appreciative of the Long Grove Park District for their stewardship and programs that they run all with volunteers.

#### **Country Club Estates Residents:**


- Country Club Estates neighborhood residents can enter and exit via Checker Road between 7 a.m. and 11 a.m.
- Schaeffer Road (paved) will be closed northbound between Checker Road and Route 53 from 7 a.m. to 11:15 a.m. The southbound lane will be open.
- Sumter Drive, Chickamauga Lane, Holy Court, Country Club Drive, Tanager Way: please drive with caution as runners will be on the side of the roads from 7 a.m. and 11:15 a.m.

#### Other Affected Roads:

- Robert Parker Coffin Road: Closed between Archer Road and Schaeffer Road from 6:45 a.m. to 11:15 a.m.
- Old McHenry Road: Controlled intersection at Robert Parker Coffin Road intersection from 6:45 a.m. to 11:15 a.m. Sheriff will allow cars to pass through runners.
- Schaeffer Road (gravel): Closed to through traffic between Robert Parker Coffin Road and Route 53 from 7 a.m. to 11:15 a.m.

# The Long Grove-Kildeer Garden Club Celebrates 50 Years!

he Long Grove-Kildeer Garden Club was formed in 1971 by Long Grove residents Betty Coffin, Barbara Turner and Beverly Bystricky. The initial club was small, five or six women, and they would meet in each other's homes.

Barbara's family donated their Long Grove cabin to the Long Grove Park District, and it became Reed-Turner Woodland Nature Center, and the new meeting location for the Garden Club. Decades later, the Club still holds its meetings there.

Back in the day, the Garden Club was about flowers and floral arrangements, but they would also make holiday favors for local nursing homes and hold fashion shows, along with formal teas and luncheons.

Betty, whose husband, Robert Parker Coffin, was the Village President of Long Grove, initiated a free daffodil program. Village Trustees approved it, and thus started Long Grove's long-standing tradition of supplying free daffodil bulbs to residents to plant along Village roadsides.

Over the years, the Long Grove-Kildeer Garden Club's membership has grown to more than 40 members from more than twelve different towns. Today's club is a casual, friendly group of men and women ranging from the novice to master gardeners. The club fosters goodwill and friendship among its members and guests. Presentations include such topics as: Native Shade Gardens, Soil Health of Your Garden, along with Pest and Disease Control. Field trips have included Cantigny Gardens, the Japanese Garden and Morton Arboretum. The group also holds social gatherings including a holiday party and a winter soupfest in a barn. An annual plant sale and a garden walk of beautiful private landscapes help to raise funds.

The Garden Club meets the second Monday of the month at the Reed-Turner Woodland Nature Center at 3849 Old McHenry Road in Long Grove, unless there is a field trip scheduled. ## **Consider Quitting Plastic**

Plastics are part of so many products that we use, and therefore a large part of our everyday lives. Experts say that while these items provide convenience, they are harming our environment - even before they end up in our homes. According to Consumer Reports, this is because plastics are made of fossil fuels, and their production emits greenhouse gases and dangerous chemicals into the air, land and water. Additionally, while recycling opportunities continue to grow, the substantial amount of plastics produced in our country cannot be recycled, and are ending up in our landfills. Once there, plastics can break down into microplastics and further contaminate our water, air and food. So, how can you help? You can take simple steps to reduce the demand for, and the amount of plastics used, from a truly grassroots level. See some tips below:

- · Bring your own reusable bags wherever you shop.
- Avoid purchasing fruits and vegetables packed in plastic wrapping of any kind.
- Stop using zipper food storage bags and use reusable containers instead.
- Stop using plastic bags for trash and for picking up after dogs. Use paperbased alternatives whenever possible.

- Avoid buying drinks in plastic bottles and choose aluminum instead which is more easily recycled.
- Switch to reusable water bottles and refill them instead of buying new.

While these steps may seem small or even inconsequential, experts say they can make a larger impact over time if everyone pitches in and does their part. For more tips on how to quit plastic, visit consumerreports.org/environment-sustainability/how-to-quit-plastic/.

# **Keep Deliveries Safe From Porch Thieves**

hile online shopping has its advantages, especially during a pandemic, there is a lingering worry about packages being stolen if you are not able to collect them right away. The holiday period presents additional challenges due to an anticipated uptick in online purchases. Fortunately, there are several ways you can help keep your packages safe this season:


- Install a doorbell video camera or a security camera for your porch.
- Add delivery instructions with the shipper to have packages delivered to a safe location other than your front porch, or have your packages delivered to your place of work.
- Ask a neighbor to pick up packages for you if you are not going to be at home.
- Use curbside pickup for purchases made from local stores or retailers.
- If you're shopping on Amazon, select one of their locker banks for deliveries. Lockers are easy to use and available at several locations in the area, including convenience stores, grocery stores and gas stations.

- For packages shipped by FedEx, you can request to have them delivered
  to a nearby Walgreens, where they can be held for you and you can

## History Corner Long Grove Then and Now: Marathon Gas Station



he Marathon Gas Station at 209 Robert Parker Coffin Road was opened in 1958 as Mel's Standard by longtime resident Mel Towner, who built most of the building. Over the years there were a couple of additions, and the business became Mel's Amoco and ultimately Mel's Marathon, as it is today. Randy Towner, the older son of Mel and Dolores Towner, runs the business, which still sells self-serve gas, and also handles towing for the Lake County Sheriff's Department. Some interesting historical notes: Towner Green, at 132 N. Old McHenry Road, is still owned by the Towner family. The business that is set back from the road at the property, Corked Wine Bar, was at one time the Towner family home - and where Randy and his younger brother Wendell grew up. Mel and Dolores are buried in the Long Grove Cemetery.
