Dear Village of Long Grove Resident:

On behalf of the Village of Long Grove, we would like to notify you that Peter Baker and Son Company and their subcontractors are scheduled to begin work on North Krueger Road from Gilmer to Illinois Route 22 on Monday, May 10, 2021, weather permitting. You may have noticed the advanced construction notification signs.

Construction will include soil erosion and sediment controls and selective tree and brush removal, asphalt pavement reclamation, road widening, storm sewer installation, grading of ditches, asphalt pavement removal (milling), pavement patching, Hot-Mix Asphalt binder course, Hot-Mix Asphalt surface course, restoration of disturbed areas, and other associated improvements.

The construction will be done in three phases:

1. Phase I Eleanor to Thimbleweed – N. Krueger Road will be closed to through traffic in this area from approximately June 7th to June 24th. A detour will be posted; see map on reverse side.
2. Phase II Thimbleweed to Gilmer – N. Krueger Road will be closed to through traffic in this area from approximately June 25th to July 17th. The detour will be remain in place.
3. Phase III IL 22 to Gilmer – N. Krueger Road will be open to traffic but still be under construction. There will be times the roadways will be limited to one-lane. At those times, traffic will alternate directions under flaggers.

The construction work is scheduled to be completed in mid-August, weather permitting. Weekly project updates will be posted to the construction website for this project: <http://kruegerroadconstruction.com/>

This project will cause inconvenience. We appreciate your understanding and cooperation, in advance, in helping improve the Village of Long Grove.

All driveway aprons will be adjusted to match the new pavement edge. Please note that neither the Village nor the contractor can be responsible for damage to private utilities that are in the public right-of-way, for example, pet fences or irrigation lines. If these utilities are damaged, it will be the homeowner's responsibility to make repairs after the scheduled work is completed.

Transportation and mail will continue to run regular routes. Garbage pick-up will also remain on Friday's during the course of the project. We anticipate substantial completion of this project by mid-August.
