There is still a couple thousand yards of material that needs to be removed. To date N&J Development have not committed to a schedule to get this completed. Village Engineer Perry and Village Manager Jackson will plan a meeting with N&J Development to discuss deadlines and consequences for not meeting those deadlines.
