



**MINUTES OF THE VILLAGE BOARD OF LONG GROVE
Tuesday, December 14, 2021, at 7:00 P.M.

CALL TO ORDER:

At 7:00 P.M., Village President Jacob called the December 14, 2021, Village Board Meeting to Order. Village President Jacob started the meeting by reading the following statement:

“Due to the Governor’s statewide disaster declaration relating to the COVID-19 pandemic and current public health guidelines for social distancing, I have determined that it is not prudent for the members of the Village Board or staff to convene in-person for tonight’s meeting. Therefore, the members of the Village Board are attending this meeting by video conference. Those same conditions require barring access to the public for in-person attendance. In light of those limitations, the public is invited to attend and listen to the meeting through Zoom platform or by phone as indicated on the meeting agenda. To comply with the Open Meetings Act requirements for virtual meetings, tonight’s meeting is being recorded.”

Item #3: Public Comment

John Kopecky reported that fuses will be replaced in light poles downtown.

Long Grove came in second place in a nationwide competition as “Christmas Town”. Long Grove was the only town in Illinois to place.

Item #4: Public Safety Reports: Lake County Sheriff’s Office; Long Grove Fire Protection District, Countryside Fire Protection District

There were no representatives from the Lake County Sheriff;s Office, Long Grove Fire Protection District or Countryside Fire Protection District..

Village Manager Jackson reported that he will be meeting with the new fire chief of the Long Grove Fire Protection District to discuss joint concerns.

Item #5: Discussion and Consideration of Funding Request to Support Midwest Sustainability Group Initiative

Barbara Klipp of the Midwest Sustainability Group Initiative provided a report on efforts to maintain, protect and improve the 53 Corridor. She also shared a link to an interactive map that details the areas concerned. Goals for 2022 are to develop grass roots teams, organize individual meetings with appropriate representatives and participate in public hearings and town halls to continue to protect the 53 Corridor.

Item #6: Village Engineer’s Report

Village Engineer Perry provided an update on the ongoing projects in the village. The construction of Stempel Parking Lot is wrapped up for the year with completion of striping and signage taking place in Spring 2022.

There was discussion regarding a sidewalk connection from the Sunset Foods parking lot to the path along Route 83. Village Engineer Perry will follow up with the owners of Sunset Grove to discuss safe sidewalk alternatives.

Discussions have continued regarding Lake Michigan water connection to the downtown. Village Engineer Perry and Village Manager Jackson are gathering information regarding scope and funding. The goal is to present their findings at the January 11, 2022 board meeting.

Village Engineer Perry followed up on the overheight detection system for the covered bridge in downtown Long Grove. Three proposals have been received. A joint staff review meeting is being organized and a report will be provided to the board in 2022.

There was discussion regarding consistent signage throughout Long Grove. Village Manager Jackson will follow up.

Village Manager Jackson reported on the development meeting for the area known as the South 15. He presented three questions to the Board so the developers could formulate a plan for the next step. The board was asked their opinions on 1) Does the village board envision property ownership or rental for the individual residential units that may be developed on that parcel 2) How does the village board feel about multi- family and not full retail 3) What building height requirement would the village board find acceptable (currently 35 foot maximum)

Another meeting with the property owners and developers will be scheduled to present the opinions of the board members.

Item #18: Discussion of Allowable Uses for ARPA Funds

Village Manager Jackson provided the board with a list of funding opportunities for informational purposes. The first ARPA report is due in April.

Village President Jacob reported that he had attended a meeting with Vernon Township to discuss the

formation of a commission to attract funding to support green initiatives and help residents implement green technology. Village President Jacob asked if there were any objections on continuing with these meetings. No one had any objections.

Trustee Michaud reported that she had met with the Stevenson High School marketing teachers to discuss the marketing collaboration project that took place in November 2021. The project was a success and there are plans to organize another collaboration in Fall 2022.
