### Item #14: Village Planner's Report

Village Manager Jackson provided the Village Planner's report. There was discussion regarding the review and approval process of the Architectural Commission. The next Architectural Commission meeting is scheduled for August 29, 2022.

There was discussion regarding the sign and landscaping issues at New Perspectives. Trustee O'Reilly formally appealed the Architectural Commission review and approval of new signage and landscaping at

New Perspectives based on the longstanding landscaping issue at the property. The appeal will be presented to the village Board at a future meeting.

## **Item #15: Village Engineer's Report**

*Village Engineer Perry provided updates on the following projects:* 

- The village received the permit from Lake County DOT to widen access at Old McHenry Rd. He is working on a time and action plan with the contractor.
- The light at the corner of Robert Parker Coffin Rd and Old McHenry has been received but installation is not scheduled.
- The LCPWD project at Rte 83 south of Rte 22will resume on July 25 and be complete within 3-months. There will be off-peak lane closures and residents will be notified via social media and constant contact.
- The Arlington Heights Road Reconstruction project is moving forward with construction anticipated in 2024 and 2025.

# <u>Item #16: Discussion and Consideration of Approval of the Quote from Corrective Asphalt Materials in the Amount of \$56,259.50 for Reclamite Application/Road Preservation</u>

Village Engineer Perry presented a proposal to apply reclamite to roads resurfaced in 2018, 2019, and 2020. Reclamite is reported to extend the life of resurfaced roads by 5-7 years. There was discussion regarding any documentation showing actual benefits of reclamite application and the possibility of testing the efficacy on Long Grove roads. Village Engineer Perry will work on a process to study the efficacy of reclamite in Long Grove comparing untreated roads to treated roads. There was also discussion regarding including this item in the paving budget for the future.

Trustee O'Reilly moved to approve the Quote from Corrective Asphalt Materials in the Amount of \$56,259.50 for Reclamite Application/Road Preservation; seconded by Trustee O'Connor

Village Manager Jackson recommended the grant be denied based on the current grant processes resolution. Trustee O'Connor asked for a moratorium on the community grants moving forward until the issue is resolved. The request for a moratorium will be placed on the agenda for a future meeting.

### **Item #18: Village President and Trustee Reports**

President Jacob reported that he had attended the recent Rte 53 Task Force Meeting. President Jacob provided a presentation to the task force highlighting Long Grove's priorities, community interest and proposed use for the land.

President Jacob reported that a written recommendation from the task force is due on 12/31/22 to Governor Pritzker. President Jacob will follow up to confirm who will be writing the recommendation.

Trustee Kritzmire provided an update on refinancing the bonds for the Rte 83 water SSA. Legal costs are higher than the numbers originally estimated by the bank which decreases the savings of refinancing. There was consensus among the board to reevaluate in 6 months.

Trustee Michaud presented an overview of the Invasive Plant Pilot Grants Program. She asked for any comments/suggestions as she prepares a final draft to be presented to the Board for final approval. The Board suggested that phragmites and teasel be added to the list of invasive plants.

Trustee Tinucci reported that he will be providing an update on virtual inspections at the next Board meeting.

### **Item #19: Village Manager's Report**

Village Manager Jackson provided an update on graffiti on the Rt. 83 tunnel and Robert Parker Coffin bridge. The quote to remove the graffiti from the Rt. 83 tunnel is \$5000. There was discussion regarding adding gates to both ends of the tunnel to close off access to the tunnel from dusk to dawn. Installation of cameras in the area is also being considered.

Village Manager Jackson reported that the audit is currently under way and Trustees will be receiving audit letters that they must respond to. ARPA quarterly reporting is complete.

Village Manager Jackson reported that he is currently addressing an extensive number of code enforcement issues/disputes between neighbors in the village.

Village Manager Jackson reported that Waste Management is changing service days to Wednesday (village-wide) starting August 1, 2020
