# Item #12. Village Engineer's Report

*Village Engineer Perry provided updates on the following projects:* 

- Access widening for Stempel parking lot is completed
- Ela Township is creating a proof for parking lot entrance signs that will be presented to board for final approval. There was discussion regarding the need for uniformity of signs throughout the village.
- Checker Road traffic calming beta testing is scheduled to begin. This will include baseline traffic counting and electronic speed radar which will collect both speed and volume data.
- *Reclamite application was applied to the approved roads and is complete.*
- An application for the Illinois Transportation Enhancement Program Grant is being prepared for the Old McHenry Road Pathway (Downtown to Route 22) and will be presented at the next meeting.
- Route 22 widening is now scheduled for 2024-2028. There was discussion regarding working with neighboring towns to encourage IDOT to prioritize this project. Village Manager Jackson will reach out to neighboring Village Managers.
- Village Manager Jackson is in legal communication with New Perspectives in regard to landscaping deficiencies.

*Village Trustee Kritzmire reported that she is working with village accountants to revise reports to reflect changes approved by the board at the August 9, 2022 meeting.*
