<u>Item #5. Public Safety Reports – Lake County Sheriff's Office; Long Grove Fire Protection</u> <u>District; Countryside Fire Protection District</u>

Detective Tim Fish of the Lake County Sheriff's office provided an update on the recent home burglaries in Long Grove and surrounding communities. Det. Fish indicated that some but not all of the burglaries are associated with a South American group. This is a nationwide issue with many departments involved in investigating and apprehending the individuals. Det. Fish recommended residents use cameras, outdoor lighting, safes, alarms and motion detectors to deter the burglars as well as make use of the Lake County Sheriff's House Watch program while on vacation.

Item #12. Discussion and Consideration of Approval to Engage Wold Architects for Services related to the Rebuild/Remodel of Village Hall

Village Manager Jackson presented the village staff recommendation to engage Wold Architects to conduct a village hall conceptual design study at a cost of \$12,500 (to be charged to the ARPA fund). This study would assess the needs for the village hall and come up with a plan to expand the village hall on the current site. Village Manager Jackson clarified that this study would determine if it's feasible to

keep the village hall on the current site. Matt Bickel from Wold indicated that the report would include a conceptual design for the village hall and that plan would be owned by the village. Wold will work with village staff and trustees to determine their wants and needs. Alternate possibilities for a future village hall will continue to be researched.

Trustee O'Reilly moved to approve village staff to engage Hunden Strategic Partners for services relate to the rebuild/remodel of village hall; seconded by Trustee Kritzmire

<u>Item #13. Discussion and Consideration of Approval to Engage Hunden Strategic Partners for</u> <u>Services related to a Hotel Feasibility Study</u>

Village Manager Jackson presented the village staff recommendation to engage Hunden Strategic Partners for services related to a hotel feasibility study to establish a boutique hotel on the property known as the South 15. The cost of the study is \$35,000.

There was discussion regarding the possibility of including a second location for a hotel within Long Grove (South Gateway) in the study. Rob Hunden from Hunden Strategic Partners indicated that this could be done by running financial modeling for two scenarios at two sites at an additional expense.

Trustee O'Reilly moved to approve Village Manager Jackson to engage Hunden Strategic Partners for Services related to a Hotel Feasibility study not to exceed \$39,000; seconded by Trustee Tinucci

After further discussion Trustee O'Reilly withdrew her motion to approve Village Manager Jackson to engage Hunden Strategic Partners for Services related to a Hotel Feasibility study not to exceed \$39,000; Trustee Tinucci withdrew his second.

Village Manager Jackson will continue discussions with Hunden Strategic Partners and refine the proposal to discuss a second site and clarify the scope of work.

•Trustee O'Reilly

Trustee O'Reilly gave background on the Robert Parker Coffin Bridge as well as the work she has been involved with relating to low clearance signage at Robert Parker Coffin Bridge. Trustee O'Reilly presented various options to prevent bridge strikes. These included:

- Signage on each bridge post at eye level stating "low clearance" along with a *flashing/blinking warning*,
- Determine most effective signage and declutter current signage
- Install a physical steel barrier on the approach to the bridge

Trustee O'Reilly reminded the board that the most effective protection for the bridge is the steel structure that was installed. This has kept damage to a minimum. Trustee O'Reilly, Village Engineer Perry, Village Manager Jackson and Jim Carmichael will meet to review options and determine cost-effective solutions that will prevent bridge strikes. They will present their findings to the Board for review and approval.
