

#### **Economic Development**

- Key Village Goals:
  - Maintain the quality of the village
  - Preserve zero Village property tax
  - Increase sales tax revenues to fund Village initiatives







#### Activity:

- Village Established a new South Gateway TIF by Menards end of 2020.
- ▶ New businesses 2020 to present: 10 new businesses, 5 closings
- Business Applications in Process:
  - Near Menards: Referred to PCZBA a Self Storage & Indoor Shooting Range
  - ▶ In the downtown: Oatflow Café, Hot Dog Eatery, & a Tea Shop
- ▶ Approved (1) new PUD: Phillips Estates, 19 homes 35 acres south of Cuba Rd. across from Glenstone.

## Completed Projects 2020 & 2021

- Robert Parker Coffin Bridge (\$ 250k DECO Grant, 51k LG HS, Box Truck Insurance Co 306k
- ► Stempel Parking Lot (200K Grant)
- RPC Pathway –Downtown to Sunset (106k matching Grant)



## Village Road Paving Update

70% of Public roads will be repaved in past 8 years.
Relative to the 15-year plan, we are 2.5 years ahead of schedule.

#### Completed:

▶ 2020: West Cuba Road 393K

▶ 2021: North Krueger Rd – Net cost to Village \$ 573K on a \$ 1.9m Project with Federal Funding.

2022 in Process: \$ 1.042M

- Oak Grove Drive & Oak Grove Circle
- Chickamauga Lane
- Port Clinton from Rt83 to Forest Glen

70% Complete No Tax!

#### Status of State / County Highway Improvements

#### **County Roads:**

- Widening Gilmer & Midlothian Intersection: Under construction w/ completion Spring 2023
- Widening Aptakisic from Route 83 to Buffalo Grove Rd: In Phase 2 Design & construction scheduled for 2023.
- Arlington Heights Rd Lake Cook to Rt 83: In Phase 2 Design Engineering. Construction planned for 2023.

#### **State Highways:**

- Route 22 widening Quentin to Route 83: In Phase 2 Design w/ construction schedule unknown.
- Route 22 & 83 Intersection improvements: In Phase 1
  Feasibility Study. In multi-year 2023-2027 construction plan.
- Route 83/60 widening & overpass CNR RR: In Phase 2
  Design Engineering but no planned construction date.


Aligned with Lake County's Consensus Plan - 3 of the priority projects are in / near Long Grove.



**5** Project Priorities Highlighted in 2017



- US 45 (IL 60 to IL 22)
- IL 60/63 (IL 176 to EJ&E RR, grade separation)
- IL 131 (Sunset Ave to WI line)
- US 45 (IL 132 to Washington St)
- . IL 22 (Quentin Rd to IL 83)



#### Route 53 Extension Update

- ▶ 25M Environmental Impact Statement cancelled by Tollway in 2019.
- ▶ Discussions starting on how to re-purposed the corridor & the 1,100 acres of land purchased by IDOT for \$ 54.3M.
- ► The IDOT doesn't own all property in the corridor but they own most of the land in a sub area that is defined in our comprehensive plan for residential / commercial development.
- Sub Area 1: Midlothian & Rt. 83



## Alternative Land Use Task Force Established via Joint House Resolution

#### Charter of the taskforce is to study:

- 1. The cost, feasibility, and environmental impact of alternative uses of the expansion land, including any potential impact on flooding in the area,
- 2. The short and long-term economic impact to the region, and
- 3. All options for funding alternative uses.
- Must meet minimum 4 times (3 meetings to date)
- Written recommendation before 12/31/22


#### Use of American Rescue Funds

## Village Finances Highlights


- ▶ Long Grove currently has \$4.232M in reserves (as of 3/31/2022)
  - ▶ Represents 125% of \$3.374M general expense budget; higher than many municipalities because we don't levy a property tax.
- Second Tax Increment Financing (TIF) district created in 2020
  - ▶ Anchored by Menards & provides ability to recapture infrastructure expenses
- Change in financial institutions for banking, savings, and investments needs
  - Greater security & strengthening of financial management best practices
- Heron's Landing SSA Bonds Refinanced
  - ▶ Interest rate reduction provided homeowner savings of \$421 per year / total of \$8,420 with final maturity still 2041 on original 30-year bonds.
- Comprehensive village financial policies & procedures are subjected to ongoing evaluation.


