RESOLUTION NO. 2020-R-\_\_\_\_

**A RESOLUTION AWARDING A CONTRACT FOR THE  
FY 2020/21 VILLAGE ROAD PAVING AND MAINTENANCE PROGRAM**

**WHEREAS**, the Village of Long Grove (the "**Village**") owns and maintains various roads within the Village's corporate boundaries and undertakes routine maintenance and re-paving of those roads from time to time; and

**WHEREAS**, the Village President and Board of Trustees have determined that it is necessary and desirable to undertake re-paving and other repairs to certain road segments within the Village during fiscal year 2020/21 (the "**Village 20/21 Road Program**"); and

**WHEREAS**, in order to secure more competitive pricing and other bidding efficiencies, the Village has solicited bids for the Village 20/21 Road Program in conjunction with the Village of Kildeer ("**Kildeer**") and Ela Township, with the Village serving as the lead agency for the entire project (the "**Contract**"); and

**WHEREAS**, the Contract includes road paving and maintenance work ("**Work**") for the Village 20/21 Road Program, as well as Work to be completed within Kildeer and Ela Township; and

**WHEREAS**, bids for the Contract were received on March 12, 2020; and

**WHEREAS**, the Village has reviewed the bids received for the Contract and has determined that *Peter Baker and Son Company* was the lowest responsible bidder; and

**WHEREAS**, the bid submitted by *Peter Baker and Son Company* is in the total amount of \$2,170,111.90, of which \$1,011,390.82 is for Work to be completed within the Village and \$1,158,721.08 is for Work to be completed within Kildeer and Ela Township; and

**WHEREAS**, the award of the Contract to Peter Baker and Son Company will be subject to: (i) approval by the Village Board of Kildeer for the portion of the Work to be completed within Kildeer, and (ii) approval by the Township Board of Ela Township for the portion of the Work to be completed within Ela Township; and

**WHEREAS**, the President and Board of Trustees of the Village (the "**Village Board**") hereby find and determine that the bid submitted by *Peter Baker and Son Company* is the most favorable to the interests of the Village and its residents; and

**WHEREAS**, the Village Board also finds and determines that the Work within Long Grove should include the entirety of the Village 20/21 Road Program, including all alternative bid elements; and

**WHEREAS**, the Village 20/21 Road Program includes both resurfacing and 18" shoulder widening along Cuba Road; and

**WHEREAS**, the Village Board further finds and determines that, notwithstanding the fact that the current configuration of Cuba Road does not fully conform with the recommended design standards for such roadways as promulgated by the Illinois Department of Transportation, the proposed resurfacing and 18" shoulder widening of Cuba Road as included in the Village 20/21 Road Program can be completed within the existing right-of-way corridor and will enhance the overall safety of Cuba Road for its intended uses and users; and

**WHEREAS**, the Village Board therefore finds and determines that it is necessary and appropriate to undertake the Village 20/21 Road Program in order to promote and protect the safety of motorists and the general public and to preserve the roadway assets of the Village, which is in the best interests of the general welfare of the Village and its residents;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS**, as follows:

**SECTION ONE. Recitals.** The foregoing recitals are incorporated herein as the findings of the Board of Trustees.

**SECTION TWO. Award.** The Village hereby awards the FY 2020/21 Road Paving and Maintenance Program Contract to *Peter Baker and Son Company*, in an amount not to exceed \$2,170,111.90, provided that: (i) such Contract shall specify that the Work to be completed within Long Grove shall be in an amount not to exceed \$1,011,390.82; and (ii) such Contract shall be

subject to approval by Kildeer and Ela Township prior to its execution by the Village. This Contract award shall be further conditioned upon receipt of all contractually-required documentation and such other additional information as may be requested by the Village Manager in accordance with the Contract, all in a form acceptable to the Village.

**SECTION THREE. Effective Date.** This Resolution shall be in effect from and after its passage and approval in the manner provided by law.
