**AN ORDINANCE ADOPTING THE VILLAGE BUDGETS FOR FY 2020-21**

**WHEREAS**, in accordance with Section 8-2-9.1 *et. seq.* of the Illinois Municipal Code, 65 ILCS 5/8-2-9.1 *et seq.*, and Chapter 10 of Title 1 of the Long Grove Village Code, the President and Board of Trustees of the Village of Long Grove have adopted the budget officer system; and

**WHEREAS**, pursuant to Section 8-2-9.4 of the Illinois Municipal Code, 65 ILCS 5/8-2-9.4, and Section 1-10-5 of the Village Code, the Village is required to adopt an annual budget before the beginning of each fiscal year; and

**WHEREAS**, in accordance with Section 8-2-9.9 of the Illinois Municipal Code, 65 ILCS 5/8-2-9.9 and Section 1-10-6 of the Village Code, notice of a public hearing was duly published on March 13, 2020, in the *Daily Herald*, a newspaper of general circulation within the Village; and

**WHEREAS**, in accordance with Section 8-2-9.9 of the Illinois Municipal Code, 65 ILCS 5/8-2-9.9 and Section 1-10-6 of the Village Code, the annual budget for FY 2020-2021 (the "**Draft 20/21/Budget**") has been available for public inspection since March 12, 2019; and

**WHEREAS**, furthermore, in accordance with Section 8-2-9.9 of the Illinois Municipal Code, 65 ILCS 5/8-2-9.9 and Section 1-10-6 of the Village Code, a public hearing was duly held on April 14, 2020; and

**WHEREAS**, the Draft 20/21 General Fund, Capital Fund & MFT Budgets had originally projected \$4,789,209 in revenues and \$4,789,209 in expenses, including without limitation \$1,649,040 in Capital Improvement Projects.

**WHEREAS**, as a result of the effects of the COVID-19 pandemic, the President and Board of Trustees have determined that it is necessary to dramatically adjust the Draft 20/21 Budgets in light of declines in projected revenue and resulting reduction in services and deferral of needed capital projects; and

**WHEREAS**, in light of the effects of COVID-19, the President and Board of Trustees have further determined that it is necessary, appropriate, and in the best interests of the Village and its residents to adjust the Draft 20/21 Budgets and to adopt:

- (a) the FY 2020-2021 “General Fund & Capital Improvements Budgets”, in the form attached to this Ordinance as Exhibit A; and
- (b) the FY 2020-2021 “Other Funds Budgets” for the following funds: IL 83 Tax Increment Financing (TIF) District; IL 83 Water Special Service Area (SSA); Water; Open Space and Motor Fuel Tax (MFT) in the form attached to this Ordinance as Exhibit B,  
(collectively, Exhibits A and B shall be referred to as the “**FY 2020-2021 Adjusted Budget**”);

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Long Grove, County of Lake, State of Illinois, as follows:

**SECTION ONE.**      **Recitals.**      The foregoing recitals are incorporated into this Ordinance as findings of the President and Board of Trustees.

**SECTION TWO.**      **Adoption of FY 2020-2021 General Fund Budget & Other Funds Budgets.**      The Village of Long Grove's FY 2020-2021 Adjusted Budget is hereby approved in the forms attached to this Ordinance as Exhibits A and B.

**SECTION THREE.**      **Effective Date.**      This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form in the manner provided by law.
