Since 2012, **Sam Toia** has served as President & CEO of the Illinois Restaurant Association (IRA), a non-profit trade association representing the state's largest private sector employer, with projected employment in 2019 of 588,000 people and more than \$30.1 billion in annual sales. The IRA owns and produces Chicago Gourmet – the annual food and wine festival held in Millennium Park that unites hundreds of restaurants, chefs and beverage experts and more than 14,000 attendees for a weekend filled with food and drink tastings, cooking demonstrations, interactive events seminars and more. Prior to his election, he served as the IRA's Chairman of the Board.

Toia is a graduate of DePaul University and a specialist in community and government relations. Previously, he was a Board Member for McPier (McCormick Place Navy Pier) from 2003 to 2010. In 2011, Toia was appointed to the Zoning Board of Appeals. As President & CEO of the IRA, Toia is responsible for managing day-to-day operations of the association. He is passionate about local, state, and federal issues affecting the hospitality industry.

Lawrence J. Mackey is Director of Environmental Health with the Lake County Health Department located in Libertyville, Illinois. Mackey joined the Lake County Health Department in 1990, starting as an inspector in the Food and Water Well Programs before being promoted to Coordinator of the Food Program in 1995. In 2009, he was promoted to Deputy Director of Lake County Health Department's newly formed Population Health Services Division, overseeing several Environmental Health programs. In 2019, Mackey was named Director of Environmental Health where he coordinated the recent County efforts to conduct air monitoring for ethylene oxide and is the Health Department's lead in COVID-19 related enforcement concerns.

Mackey is a past fellow of the University of Illinois at Chicago Mid-America Regional Public Health Leadership Institute, and is an Illinois Licensed Environmental Health Practitioner. He received a B.A. degree in Biology with Environmental Emphasis from Lawrence University in Appleton, Wisconsin and has credits toward the Master of Public Health program at the University of Illinois in Springfield.
