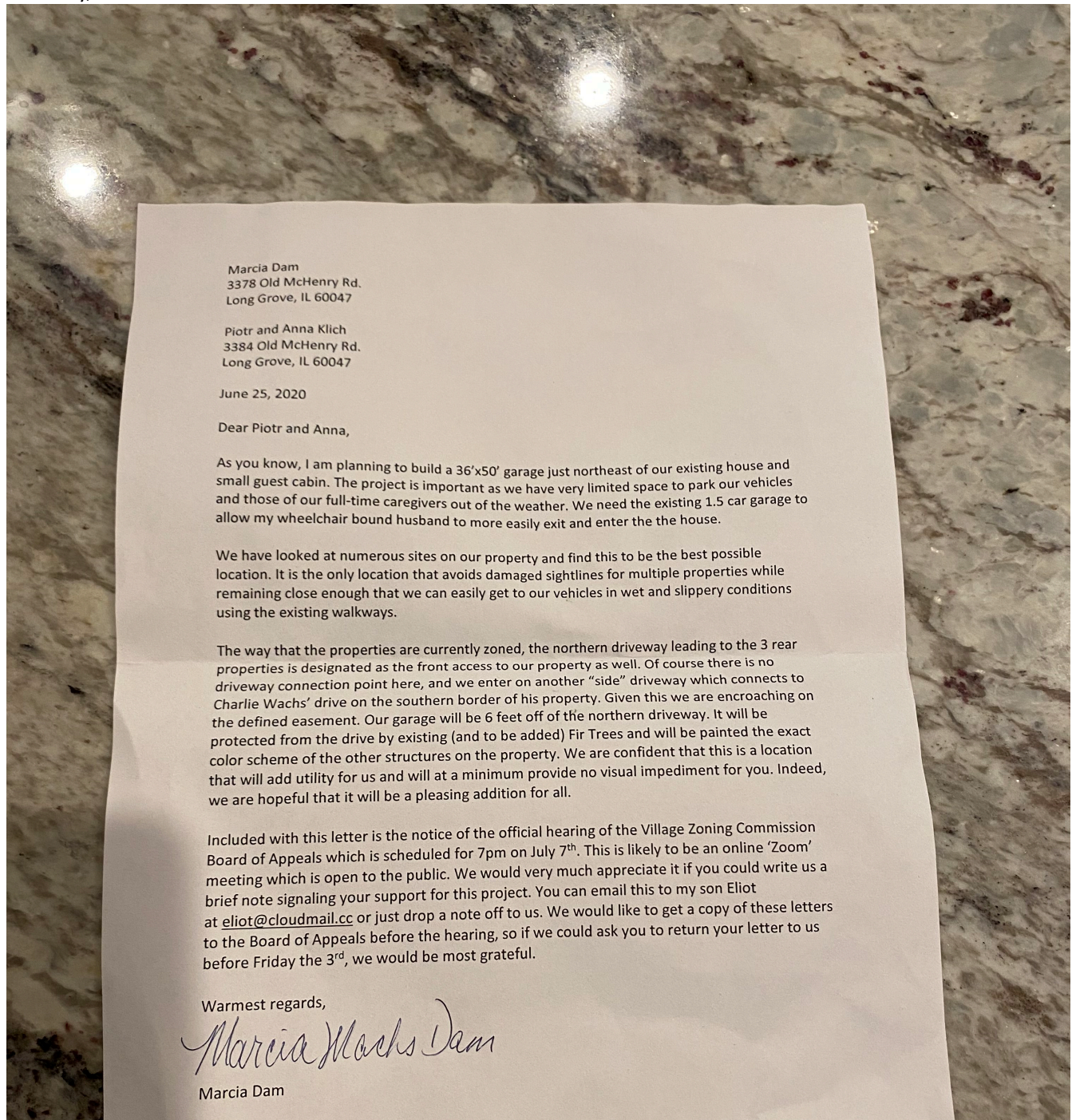

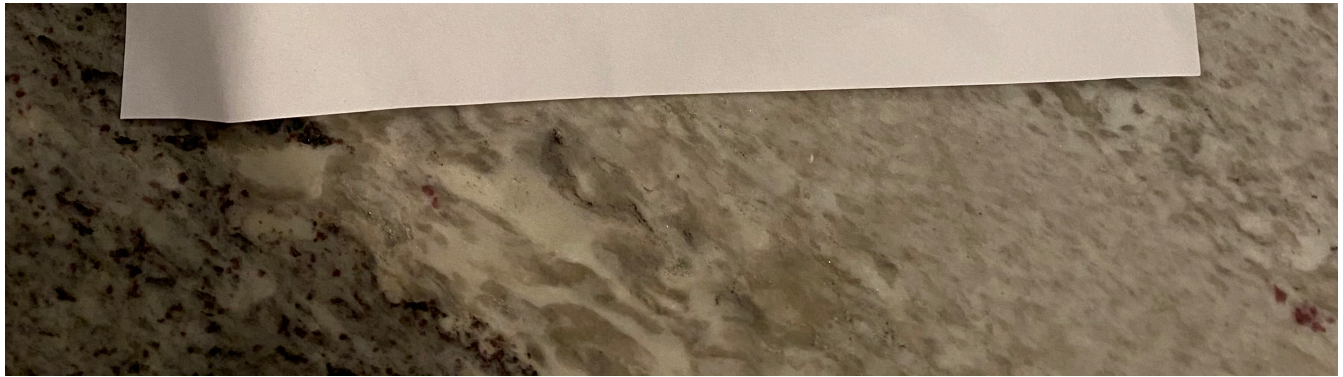

I hope that the below will meet your needs at your upcoming Zoning Board of Appeals hearing.

First, I want you to have a permanent easement that is consistent with the way our family property has always been used. I was under the impression that an easement had already been granted by our father to allow 3378 to use the driveway on the south edge of the 3376 property as its main access.
