Good afternoon Mr. Lothspeich,

I am writing on behalf of Long Grove Community Church in my capacity as Executive Pastor.

The letter announcing the consideration of a resolution to rename Robert Parker Coffin Road to Long Grove Road and other changes has been forwarded to me for review and response.

In the letter it states – *“Whether a public road or private lane, if the name is changed the Village will formally notify the appropriate agencies of all the property addresses affected by this change.”*
