EDC Meeting Opening Procedure/Statement During the Pandemic:

"Due to the Governor's statewide disaster declaration relating to the COVID-19 pandemic and current public health guidelines for social distancing, I have determined that it is not prudent for the members of the Economic Development Commission (EDC) or staff to convene in-person for this morning's meeting. Therefore, the members of the EDC are attending this meeting by video conference. Those same conditions require barring access to the public for in-person attendance. In light of those limitations, the public is invited to attend and listen to the meeting through Zoom platform or by phone, as indicated on the meeting agenda. To comply with the Open Meetings Act requirements for virtual meetings, this morning's meeting is being recorded."

- a. At the outset of the meeting, the Village President or the head of other public bodies of the Village should make a formal determination whether an in-person meeting is not practical or prudent because of the disaster proclaimed by the Governor [see Item a above]. This also relates to access limitations to the Village Hall. [See above for a proposed statement by the head of the public body.]
- b. During the opening roll call, each member of the public body should state whether he or she can hear what is being said, and the Clerk, secretary, or head of the public body should confirm that each such member can be heard.
- c. All votes must be taken by roll call, including motions to adjourn. The vote of each member of the public body should be identifiable to those watching or listening to the virtual meeting and should be individually recorded in the meeting minutes.
