RESOLUTION NO. 2021-R-___

A RESOLUTION APPROVING THE HISTORIC DOWNTOWN LONG GROVE BUSINESS ASSOCIATION (HDLGBA) SPECIAL EVENTS CALENDAR FOR 2021

WHEREAS, the Historic Downtown Long Grove Business Association (“**HDLGBA**”) is an Illinois not-for-profit corporation organized for the purposes of promoting business, tourism, and economic development to assist merchants and property owners in the downtown business area of the Village of Long Grove (“**Village**”), and in furtherance of such purposes the HDLGBA organizes and conducts various special events in the downtown business area; and

WHEREAS, the HDLGBA has requested that the Village approve a calendar of dates for planned special events in 2021, a copy of which calendar is attached hereto as **Exhibit A** (the “**2021 Events Calendar**”); and

WHEREAS, the President and Board of Trustees of the Village (“**Village Board**”) hereby find and determine that it is appropriate and in the best interests of the Village and its residents to approve the 2021 Events Calendar, subject to the conditions set forth in this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, COUNTY OF LAKE, STATE OF ILLINOIS, AS FOLLOWS:

SECTION ONE. **Recitals.** The foregoing recitals are incorporated into this Resolution as the findings of the Village Board.

SECTION TWO. **Approval.** The Village Board hereby approves the 2021 Events Calendar submitted by the HDLGBA, subject to the following conditions:

- (a) The Village Board’s approval of the 2021 Events Calendar is limited to approval of the special event dates set forth therein.

(b) HDLGBA shall be required to submit complete special event permit applications and obtain Village Board approval thereof in accordance with the Village Code at least **[90 days]** prior to each planned special event.

(c) All special events set forth on the 2021 Events Calendar must be conducted in compliance with all applicable federal, State, and local laws and regulations, including without limitation any public-health-related disaster proclamations, orders, rules, and regulations relating to the Coronavirus Disease 2019 (COVID-19) pandemic that may be in effect at the time of each such special event.

SECTION THREE. **Effective Date.** This Resolution shall be in full force and effect after its passage, approval, and publication in pamphlet form in the manner provided by law.
