RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF LONG GROVE AND THE VILLAGE OF MUNDELEIN FOR INTERIM PLANNING SERVICES

WHEREAS, pursuant to 65 ILCS 5/11-12 and other applicable law, the Village of Long Grove ("Village") has adopted zoning and land use ordinances and regulations and has established the office of Village Planner to facilitate implementation of such ordinances and regulations and perform related duties; and

WHEREAS, the duties of the Village Planner include to maintain the Village's comprehensive plan, review proposed subdivisions and annexations, conduct zoning and planning reviews, facilitate the review and consideration of applications relating to development projects, make recommendations to the Village Board and other Village bodies relating to planning and development matters, and perform other municipal planning work as directed by the Village Board (the "Services"); and

WHEREAS, the Village's long-time Village Planner intends to retire effective July 15, 2021, and the Village has determined that there is a need for assistance with the Services on an interim basis following his retirement; and

WHEREAS, the Village of Mundelein ("Mundelein") currently operates its own Community Development Department and has expressed its willingness to provide the Services jointly with the Village; and

WHEREAS, the Village has determined that the Services can be provided most effectively and efficiently on an interim basis pursuant to an intergovernmental agreement with

Mundelein in substantially the form attached hereto as **Exhibit A** (the "Interim Planning IGA"), which, among other things, sets forth the costs and terms for the Services to be provided by Mundelein and its Community Development Department; and

WHEREAS, the Village has authority to enter into such Interim Planning IGA pursuant to the Intergovernmental Cooperation Act (5 ILCS 220/1 et seq.), Section 10 of Article VII of the Illinois Constitution, and other applicable authority; and

WHEREAS, Village President and Board of Trustees have determined that it is in the best interests of the Village and its residents to approve said Interim Planning IGA with Mundelein in substantially the form attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, STATE OF ILLINOIS as follows:

SECTION 1: Recitals. The foregoing recitals are hereby incorporated herein as findings of the Village Board of Trustees.

SECTION 2: Approval; Execution. The Village President and Board of Trustees hereby:

- (i) Approve the Interim Planning IGA with the Village of Mundelein in substantially the form attached hereto as Exhibit A and in a final form approved by the Village Manager in consultation with the Village Attorney; and
- (ii) Authorize the Village President or Village Manager to execute, and the Village Clerk or a Deputy Clerk to attest, such Interim Planning IGA, in its final form, on behalf of the Village.
