A RESOLUTION APPOINTING JEANNE SYLVESTER AS CHAIR OF THE VILLAGE OF LONG GROVE ARCHITECTURAL COMMISSION

WHEREAS, pursuant to Title 2, Chapter 3 of the Long Grove Village Code, the Village has established an Architectural Commission ("AC") to review building permit applications and other matters delegated to it by the Village Board relating to architecture, landscaping, lighting, and similar matters in order to enhance and preserve the Village's historic features, unique aesthetics, and high-quality architectural style and design; and

WHEREAS, the members of the AC are Village residents appointed by the Village President and Board of Trustees ("*Village Board*") upon consideration of their background or expertise in fields such as architecture, engineering, building trades, and historic preservation; and

WHEREAS, there is currently a vacancy in the role of AC Chair; and

WHEREAS, Jeanne Sylvester is a Long Grove resident of 21 years with extensive education, training, and experience in architecture and history, and she has served as an AC Commissioner since 2016; and

WHEREAS, Ms. Sylvester's educational background includes collegiate and graduate level degrees in history, historic preservation, and law; and

WHEREAS, Ms. Sylvester practices professionally as an architectural historian and historic preservation consultant and has undertaken a broad range of consulting, research, writing, and photography work in that field, including advising Chicago-area municipalities regarding architectural impact, historic resource and landmark evaluation and preservation, and similar matters; and

WHEREAS, Ms. Sylvester is also a licensed attorney with expertise in local government and legislative processes and has further professional experience in municipal planning, design, and cultural affairs; and

WHEREAS, in recognition of Ms. Sylvester's extensive relevant background and expertise, her prior years of service as an AC Commissioner, and her long-term residency within Long Grove, the Village Board desires to appoint and designate Jeanne Sylvester as the Chair of the AC;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS, THAT:

<u>Section 1</u>: <u>Recitals</u>. The recitals set forth above are incorporated as a part of this Resolution by this reference.

<u>Section 2</u>: <u>Architectural Commission Chair Appointment</u>. The Village Board hereby appoints and designates Jeanne Sylvester to serve as the Chair of the Village of Long Grove Architectural Commission.
