

MINUTES OF THE VILLAGE BOARD OF LONG GROVE Tuesday, March 8, 2022, at 7:00 P.M. 3110 OLD MCHENRY ROAD, LONG GROVE, ILLINOIS 60047-9613

CALL TO ORDER:

At 7:00 P.M., Village President Jacob called the March 8, 2022, Village Board Meeting to Order. Village President Jacob started the meeting by reading the following statement:

"Due to the Governor's statewide disaster declaration relating to the COVID-19 pandemic and current public health guidelines for social distancing, I have determined that it is not prudent for the members of the Village Board or staff to convene in-person for tonight's meeting. Therefore, the members of the Village Board are attending this meeting by video conference. Those same conditions require barring access to the public for in-person attendance. In light of those limitations, the public is invited to attend and listen to the meeting through Zoom platform or by phone as indicated on the meeting agenda. To comply with the Open Meetings Act requirements for virtual meetings, tonight's meeting is being recorded."

Village Clerk Schmitke confirmed that all trustees could hear and be heard.

Item #1: Pledge of Allegiance

Item #2: Homeowner Associations: Indian Creek Estates, Helen Dorn; Cobblestone, Michael Kiefer

Indian Creek Estates was invited to the meeting but did not have a representative in attendance.

Michael Kiefer represented Cobblestone and stated that the residents appreciate the support the village provided in regard to the solar field.

Item #3: Public Comment

Trustee Borawski acknowledged that it was International Women's Day and wanted to recognize all the women of the Board and the Village.

Item #4: Public Safety Reports: Lake County Sheriff's Office; Long Grove Fire Protection District; Countryside Fire Protection District

There was no public safety report.

There was discussion regarding distributing communication to village residents of the House Watch service available through the Lake County Sheriff's Office during the upcoming spring break. Village Manager Jackson will follow up with Sargent Amber to see if there is any additional information that should be distributed.

Item #8: Village Engineer's Report

Village Engineer Perry reported that the contractor has not yet provided a schedule for completion of the Stempel parking lot. Robert Parker Coffin pathway is scheduled for completion within the next 2 weeks.

Village Engineer Perry indicated that he is reviewing options for adding additional sidewalk to the northwest corner of Robert Parker Coffin Road and Route 83. Village Engineer Perry will follow up with IDOT to clarify the possibility of expanding the area by hard topping the section with brick or asphalt.

There was discussion regarding the public meeting to address Checker Road traffic calming options. The meeting was originally planned for March 22, 2022. School Districts 96 and 125 are both on spring break that week. To allow for residents that may be out of town, the meeting will be rescheduled to April 12, 2022.

Village Engineer Perry reported that he had met with Trustee Tinucci and Trustee O'Reilly on Village Hall expansion plans. Challenges include the current septic system and also how an expansion impacts parking. Trustee Tinucci indicated that providing a clean and safe workplace is the priority. The topic will be on the agenda for the upcoming Board strategic planning workshop. Village Engineer Perry will put together a sewer project proposal and submit it to Village Manager Jackson.

Village Engineer Perry reported that the Robert Parker Coffin Road Covered Bridge APWA Project of the Year award ceremonies are scheduled. Village Engineer Perry and Trustee O'Connor will be in attendance. Village Manager Jackson will notify members of the Historical Society in case they would like to attend as well.

Village Engineer Perry reported that Ela township will address the west transition plate on the covered bridge on March 21, 2022. Village Manager Jackson will communicate this information to the village.

Item #9: Discussion and Consideration of Resolution 2022-R-XX Approving the Resurfacing of Port Clinton Road from Route 83 to the Intersection of Forest Glen, to Replace Robert Parker Coffin Road

Village Engineer Perry reported that Ela township and Kildeer have submitted their information for the joint bid for the 2022 road maintenance program. The proposal is ready to be submitted to IDOT for review and approval with a projected bid opening date of March 31, 2022. Village Engineer Perry reported that due to the condition of the pavement core on a section of Robert Parker Coffin Road he recommends addressing this section as a separate project. He recommends that the resurfacing of Port Clinton Road from Rte 83 to the intersection of Forest Glen replace the Robert Parker Coffin Road work in the 2022 Road Maintenance Program.

Village Engineer Perry will continue to look at options for addressing Robert Parker Coffin Road.

President Jacob reported that he will be attending the upcoming Route 53 Task Force meeting.

Trustee Borawski reported that he had been made aware that House Bill 4356 has been called in committee. This bill focuses on carpet recyclability and the potential to work with the carpet industry on this issue.

Trustee Kritzmire indicated that she met with Director of Operations Rosenquist for budget review. Trustee Kritzmire also reported that the TIF joint review board zoom meeting is March 17, 2022 at 7am. They will be reviewing minutes, financials and projects.

Trustee Michaud reported that she was unable to attend the recent EDC meeting but Village Manager Jackson and Roger Goble were in attendance and provided an update. Village Manager Jackson reported the EDC discussed strengthening relationships with various businesses as well as projects that are moving forward. They also discussed the Village LinkedIn account and Village Manager Jackson asked Board trustees to connect to the village LinkedIn. The EDC is waiting for direction from the Board following the Board's upcoming strategic planning meeting. Roger Goble recommended the trustees review the Lake County Commissions report on infrastructure needs in Lake County.

Trustee Tinucci reported that the village charges \$10.50/1000 gallons of water. The minimum charge per building is \$100/qtr. Trustee Tinucci suggested the board review rates in the future as well as consider a system maintenance charge. Trustee Kritzmire indicated that a rate review analysis has been completed. recently.

Item #13: Village Manager's Report

Village Manager Jackson reported that he had distributed a list of current projects to the Board.

Village Manager Jackson is meeting with village resident Ankur Jain on March 10, 2022 at 10 am in regard to climate control solutions. This will be a zoom presentation and any trustees that are interested may attend.

Village Manager Jackson will be meeting with the Village Manager of Buffalo Grove and Lake County DOT on March 23, 2022 to review the upcoming Aptakisic Rd and Arlington Heights Rd projects.

Village Manager Jackson met with the Executive Director of the Lake Zurich Chamber of Commerce to talk about opportunities to further promote the Long Grove business community. He will attend their next board meeting in April

Village Manager Jackson and village staff are working on preparing the budget presentation for the March 22, 2022 board meeting.

Trustee Tinucci questioned the snow plowing/salting portion of the invoice for the senior center sidewalk. Village Manager Jackson will get confirmation regarding this.
