

### MINUTES OF THE VILLAGE BOARD OF LONG GROVE Tuesday, May 10, 2022 at 7:00 P.M. 3110 OLD MCHENRY ROAD, LONG GROVE, ILLINOIS 60047-9613

#### **CALL TO ORDER:**

At 7:00 P.M., Village President Jacob called the May 10, 2022 Village Board Meeting to Order.

#### **Item #1: Pledge of Allegiance**

#### **Public Safety Report**

Sgt Amber of the Lake County Sheriff's office provided an update on 2 recent burglaries in the Village. He also reported an incident of graffiti vandalism in the Oak Hills subdivision. Sgt. Amber reminded everyone that the House watch program provided by the Lake County Sheriff's office is available when residents are out of town. Village Manager Jackson will put together a communication to residents regarding crime prevention.

# <u>Item #2: Homeowner Associations: Long Grove Woods, Lisa Anderson; White Oak Estates, Christina Angelos</u>

Long Grove Woods and White Oak Estates were invited to the meeting but did not have a representative in attendance. Village Manager Jackson reported that the representative from White Oak Estates was unable to attend the meeting but will be put on the agenda for a future meeting.

Village Manager Jackson provided the Village Planner's Report stating that there will be two projects going before the Architectural Commission on Monday, May 16, 2022. These include a proposed storage facility at Lake Cook and Rte. 53 and proposed deck work at Joannies Pizzeria at 255 Robert Parker Coffin Rd.

#### **Item #5: Village Engineer's Report**

Village Engineer Perry reported that the 2022 Road Maintenance Program is expected to begin May 11, 2022. Completion of the work in Long Grove is expected by the end of June 2022.

Village Engineer Perry reported that the Robert Parker Coffin Road Forcemain project is scheduled to start on May 30, 2022. He also stated that the contract indicated the hours of work on the project are 8 am to 3pm daily.

Village Engineer Perry also gave the following updates:

- Widening of the entrance to Stempel Parking from Old McHenry Rd. will commence upon receipt of the permit
- The Robert Parker Coffin Path work is complete
- The additional No Right Turn on Red signs have been placed at the intersection of Old McHenry Rd and Robert Parker Coffin Rd.
- New trees have been placed on North Krueger Road to replace the dead/dying trees

Trustee O'Reilly asked if there is a summary of village costs associated with The Grove berm project. Village Manager Jackson will provide a summary of costs.

Trustee Kritzmire asked if there were any updates regarding Village Hall expansion plans. Village Manager Jackson reported that there will be discussions and next steps within the next week.
