Village Projects / Studies / Assessments

- 1. Robert Parker Coffin Bridge
 - a. Additional due diligence being completed on advance notification / warning measures. <u>Discussion</u> and presentation forthcoming
- 2. Robert Parker Coffin Road Pathway (IDNR Bike Path Grant)
 - a. IDOT will not allow a brick expansion in their right-of-way. GHA coordinating acceptable materials with IDOT
- 3. Checker Road Traffic Calming
 - a. Temporary speed tables scheduled to be installed November 7, 2022 through November 23, 2022
 - b. Speed Tables will be available for re-use after beta testing, possibly on Robert Parker Coffin Road, west of the bridge. Our office recommends installation after winter/snow plowing season
- 4. Village Hall Expansion
 - a. Project update meeting held Wednesday, September 21, 2022. Additional due diligence being completed to use existing property
- 5. Old McHenry Road Pathway Downtown to Route 22
 - ITEP Grant (Illinois Transportation Enhancement Program) application submitted September 30, 2022
- 6. North Krueger Road
 - a. Project is in finalization and close-out stage with IDOT
- 7. Robert Parker Coffin Covered Bridge Abutment Replacement & Painting Project
 - Village Manager and GHA are working with ESI to resolve change orders so net project cost is not impacted
- 8. Mardan Estates & Woods Drainage
 - a. Plan is being reviewed for routing and land acquisition needs
- 9. Water Treatment Plant
 - a. System is in stable working condition
- 10. Arlington Heights Road Reconstruction (LCDOT; Project Manager Julian Rozwadowski)
 - a. Phase II coordination meeting held with LCDOT on July 11, 2022. Completion of design plans anticipated September 2023. Construction anticipated 2024 and 2025.
- 11. Aptakisic Road Widening (LCDOT: Contact: Kevin Carrier)
 - a. Widening from IL Route 83 to Buffalo Grove Road. Construction scheduled for 2023, pending project readiness and land acquisition
- 12. Illinois Route 22 Widening (IDOT Project 60N10)
 - a. Project letting schedule is unknown at this time. 2023-2028 Multi-Year Plan issued by IDOT; Route 22 widening scheduled for 2024-2028
 - b. Pre-final design plans anticipated February 2023
 - c. IDOT and Village to re-engage in Landscaping Enhancement discussions
 - d. <u>IDOT plans to transfer 3916 Willowbrook Road to Citizen's for Conservation, upon completion of</u> the project. GHA is working to obtain more information

e. <u>Updated information for retaining wall finish included in Board Packet. Village Board direction</u> requested

13. Route 22 and Route 83 (IDOT Project)

- a. Improvements are included in 2023-2028 Multi-Year Plan, scheduled for 2024-2028
- b. Design Engineering will likely not start next year, contrary to the Multi-Year Plan

14. Lake Cook Road Improvements (Buffalo Grove Project)

- a. Traffic Counts are scheduled for this week
- b. Formal Phase I (Feasibility Study) Kick-Off Meeting held for November 10, 2022. Phase I is not scheduled to be completed until 2024
- c. Invest in Cook funding received for Phase I Engineering only; future phases are currently unfunded.

15. Miscellaneous

- a. Archer Parking Lot bioswales are flooded. GHA soliciting proposals to clean underground pipes. Analysis of the bioswales is forthcoming, as the initial plans did not include underdrains.
- Wooten Electric replaced failed contactor for Archer Road and parking lot lights on November 4, 2022
- c. <u>Lake County Public Works confirmed two grease traps in downtown; one for Enzo & Lucia's and one for Buffalo Creek Brewery. They are reviewing files for any additional grease traps and are likely going to send letters to restaurants on the importance of grease traps</u>
- d. <u>Lake County Public Works has sent letter to 220 RPC and 209 RPC as video suggests broken</u> sanitary sewer services
- e. <u>Material stockpile remains from Lake County Public Works project at Route 83 and Route 22.</u>
 Project is complete and county is waiting for contractor to remove material

- a. Development security has not been released due to landscaping deficiencies
- b. GHA and Village Manager met with Executive Director on March 30, 2022 to review deficiencies

17. Harborchase of Long Grove

- Urban Forest Management and Tallgrass Restoration both reviewed the site and found significant deficiencies in the landscaping
- b. GHA and Village Manager met with Executive Director on March 30, 2022 to review deficiencies. Meeting with the new Executive Director scheduled for November 21, 2022

18. 3217 Route 53 - Berming & Beautification

a. <u>Site vegetation has reached the required 70% density for project close-out. Final inspection and approval needed from Village Forester for project close-out</u>

19. <u>1145 Steeple View Estates – New Single-Family House</u>

 a. Plans approved March 22, 2022. Construction has commenced. Foundation Spot Survey approved June 7, 2022. Pre-Backfill (storm sewer) passed October 13, 2022. GHA awaiting notification of construction completion

20. 1148 Steeple View Estates – Swimming Pool

a. Erosion control inspection passed on August 16, 2021. GHA awaiting notification of construction completion and As-Built Survey

21. 1358 Bridgewater Lane - Culvert Replacement

a. Final inspection passed on November 6, 2022. GHA recommends final acceptance and close-out

22. 1381 Manassas Lane - Hardscape and Drainage

a. Plans received November 14, 2022 and are under review

23. 1562 Chickamauga Lane – Drainage and Grading

a. GHA awaiting additional information
