



Since May 2020, GHA has overseen the operations of the Long Grove Water Treatment Plant. This experience is invaluable as GHA knows the systems, its pressure points and knows a brief history of performance. GHA is also uniquely qualified to be the Water Operator as we also serve as the Village Engineer. By filling both roles, communication can be streamlined if/when issues arise and capital improvements are identified.

Since becoming operator of Long Grove's Water System, GHA staff has **identified and corrected a number of deficiencies**, which include replacement of parts, including the critical flow control valve, to stabilize the system to **minimize high-pressure and low-pressure alarms**, replaced rusted reservoir hatches, analyzed the sand filtration media, and **improved processes for alarm response and chemical delivery**. Specifically, all alarms are now coded for ease of diagnosis and chemicals are now delivered and placed into the appropriate place, e.g. in the brine tank, which was not previously done. The process changes have resulted in **lower operation costs**.

#### Reliable in Emergencies

As Operator of Long Grove's Water System, the most unfortunate event came on March 16, 2020. On that date, there was a water main break that emptied the water system in less than 30 minutes. GHA staff promptly responded to the emergency, took the necessary steps to isolate the problem and restore the water system operations. Unfortunately, a 48-hour mandatory boil order was issued for the water system users and GHA coordinated the boil order with the Lake County Health Department and Illinois EPA. This incident did not result in non-compliance and **demonstrates GHA's ability to respond to unanticipated events** and restore the system in a timely fashion.

# Safety

Safety is of the utmost importance for GHA staff and operators. As experienced water operators, GHA staff is **knowledgeable in safety procedures and correct methods** to handle chemicals and operate the mechanical components of the water system. Long Grove's water operations is GHA's first O&M type contract and we **have not had any safety incidents since becoming the water operator**.

# **Project Experience**

The following represents our Team's project experience:

#### VILLAGE OF RIVERWOODS

Assisted the Village of Riverwoods in negotiating the contract with Northbrook to become the primary supplier of Lake Michigan water to the community. The project involved a new connection and metering station in Northbrook; 4;500 feet of 12-inch water main (including a 150-foot auger and jack crossing of Lake Cook Road); reservoir upgrades in Riverwoods to accept the new source; System Control and Data Acquisition and wireless telemetry improvements.

GHA fast-tracked the project and was able to complete the design, permitting and construction schedules. The new supply was operational within one year of contract acceptance.

# VILLAGE OF LONG GROVE

This references the current contract with GHA and the Village. In the period covered by this contract, significant progress was made in correcting deficiencies, improving operational processes and efficiency. We have continued successfully with initiatives identified.

#### VILLAGE OF GRAYSLAKE

Team member, Rob Ullrich (Class C) is currently the Operator for the water system in the Village of Grayslake.

#### **Contract Completion**

GHA has successfully completed all contracts within the last 10 years and not had any contracts terminated by a governmental agency within the last 10 years. Due to this exemplary record, GHA has not paid any liquidated damages, fines or penalties on their service contracts.

GHA staff will continue to operate the Water Treatment Plant as we do on the currently active contract. We will continue to treat the Village's infrastructure with utmost care, as if it were our own. Regular care will help keep the components in good working condition with the intention of reducing the likelihood of more expensive repairs later.

Due to the Ion-Exchange treatment required, daily visits to the treatment plant will be completed. The primary staff responsible for the daily operations will be **Rob Ullrich** and **Phil Freund**; they will be guided and supported by ROINC **Gary Gramhofer** and **Mike Grinnell** as illustrated on the organizational chart.

The chemicals necessary for the daily operations of the Water Treatment Plant include sodium hypochlorite and salt. Delivery of sodium hypochlorite is required approximately quarterly in 15-gallon containers and delivery of salt is required monthly on commercial pallets. GHA proposes to continue using the existing vendors for these products.

GHA has strong, established working relationships with Village staff, the Long Grove Fire Protection District and Lake County Public Works Department. Our office has interacted with the Lake County Sheriff sporadically. We have served as the Village's Engineer under our tagline, "A Personal Approach" and will continue that approach as the Village's Water Operator.

# **Operations and Maintenance Plan for Water Facility and System**

As part of the daily operations, the following information will be documented:

- usage (hours) of all distribution pumps,
- reading of distribution flow meter,
- reading of well flow meter, hydropneumatic tank level, water pressure, usage of air compressors,
- readings of both softener flow meters,
- readings of the finished water flow meter, reservoir levels, usage of both deep wells, brine solution meter, brine dilution meter, sodium hypochlorite levels, generator fuel level, and,
- test and document the water's pH, alkalinity, chlorine and hardness.

These readings and tests will be completed onsite by GHA staff. On a weekly basis, the raw water hardness will be tested and documented by GHA staff, while onsite. The fixed fee includes these items, including the purchase of the necessary supplies to complete these tests.

On a monthly basis, water samples will be taken and sent to PDC Laboratories to test for coliform and E Coli levels. These results will be submitted to the Illinois EPA for regulatory compliance.

On an annual basis, water samples will be sent to PDC Laboratories for testing of Lead/Copper, Stage 2 Disinfectants and Disinfection Byproducts, Nitrates, and VOCs.

These results will also be sent to the Illinois EPA for regulatory compliance. To date, all reports submitted by GHA have been approved and accepted.

#### **Operations Maintenance Management System**

GHA keeps an inventory of spare parts, mostly meters, and submits that information to the Village Accountant monthly or as requested. There are also some spare pumps, most critically a spare chlorine pump, at the pump station that are inventoried and rotated into service.

#### **Ten-Year Maintenance Plan**

GHA drafted a 10-year maintenance plan for the Water Treatment Plant in March 2020. In review of that draft plan, we anticipate the following capital improvements necessary within the life of this contract:

- 2021: Arch Flash (deferred from 2020) Reservoir Inspection (deferred from 2020) Rebuild Cla-Val Automatic Blending Valve Infrared Testing to inspect the high voltage cabinets Flow Meter Testing to calibrate Generator Preventative Maintenance and Load Banking Well Inspection and Annual Testing Minor building repairs Vibration Analysis for Distribution Pump #1 Rebuild Chlorine Pump New 1.5 hp Brine Pump
- 2022: Generator Preventative Maintenance and Load Banking Well Inspection and Annual Testing Hydropneumatic Tank inspection with an external pressure vessel Minor building repairs Vibration Analysis for Distribution Pump #2
- 2023: Infrared Testing to inspect the high voltage cabinets

Generator Preventative Maintenance and Load Banking Well Inspection and Annual Testing Minor building repairs Vibration Analysis for Distribution Pump #3 Rebuild Chlorine Pump Driveway sealcoat and striping

- 2024: Flow Meter Testing to calibrate Generator Preventative Maintenance and Load Banking Well Inspection and Annual Testing Minor building repairs Replace Ion Exchange Resin
- 2025: Arch flash testing Infrared Testing to inspect the high voltage cabinets Reservoir Inspection Well Inspection and Annual Testing Minor building repairs Vibration Analysis for Distribution Pump #4 Rebuild Chlorine Pump

# **Record Keeping and Reporting**

The highest standards of record keeping and reporting, as directed by applicable regulating agencies and the Village of Long Grove, will be met throughout the contract, including the Annual Report.

The personnel identified in this proposal are extremely familiar with all operational requirements and guidelines for and by the Illinois Environmental Protection Agency.



#### **Backflow Prevention & Monitoring**

GHA last completed the required backflow prevention testing at the Water Treatment Plant, through a subcontract with Mergenthaler Plumbing, in November 2019. There are three backflow prevention devices at the Water Treatment Plant.

#### Sampling and Testing

GHA will visit the Water Treatment Plant daily to take the readings, measurements and recordings as outlined in this document. The daily tests will be completed by the inspection staff while onsite. These tests are performed with litmus-type papers. The monthly and yearly tests require laboratory testing. GHA proposes to collect the water samples as required and deliver them to PDC Laboratories for testing. In GHA delivering the samples, that is a safeguard to protect the chain of custody. The fees for the monthly and yearly tests are included in the base fee.

#### **Emergency Preparedness Plan**

America's Water Infrastructure Act of 2018 requires that municipal water systems that serve more than 3,300 customers have an Emergency Response Plan. The requirement to have an Emergency Response Plan has become topic of discussion in Illinois over the last few months. As this is a relatively new requirement and, more importantly, as Long Grove does not have 3,300 customers, Long Grove does not have a formal Emergency Response Plan, nor is it required to.

GHA is very familiar with Emergency Response Plans in our experiences in Grayslake and Round Lake Beach. Chuck Bodden is certified by the American Water Works Association (AWWA) to facilitate compliance with these plans.

#### Billing

The Village of Long Grove reads the meters and invoices their customers on a quarterly basis. GHA has completed four (4) billing cycles for the Village and has seen the system progress from a manual system to a more automated system with BS&A software.

All meters in Long Grove are installed with an exterior touchpad. As the touchpads have been installed the location of the touchpads has been documented for reference. The meter reading process requires a Sensus hand-held data collector to transmit data from the meter to the reader. The reader itself holds five (5) readings, thus they need to be manually transferred multiple times during the process. Once the meters are read and the usage input, the Village has the utility module of BS&A software that can generate the customer invoice. GHA will generate, print and send the invoices. Payments are either mailed to Village Hall or paid online.

With the manual transfer of data, there are chances of inaccurate readings. As a quality control measure, our office compares the current usage with the prior quarter. If the usages are reasonably close, the invoice is generated and mailed. If the usages differ significantly, GHA will re-read the meter to confirm accuracy. There have been times that customers dispute the usage. In those cases, GHA will re-read the meter and has met with the owners to discuss their concerns. On a couple occasions, leaky fixtures have been identified by GHA as the culprit.

Another quality control measure is for GHA to review the meters for the five (5) high users on a monthly basis. It is good practice to document large uses monthly to quickly identify trends, whether they be increased usage or perhaps a faulty meter.

# Illinois EPA Compliance

*At the core of virtually all operations is IEPA compliance*. All members of the proposed Team are highly familiar with and historically completely compliant with all IEPA requirements of documentation and submission.

# **OSHA Compliance Plan**

As previously noted, safety of GHA staff is of utmost importance. GHA will continue to monitor the latest innovations and techniques for the operation of the Water Treatment Plant and will, as we commonly do, attend trainings and seminars as they are available and applicable to Long Grove's Water System.

# Permit Compliance Plan

The Village Community Water System (CWS) is regulated by the Illinois EPA and as noted, the required testing forms are submitted to the Illinois EPA on a monthly basis for permit compliance. Over the past year, GHA has also submitted various reports to the Lake County Public Works as the Water Treatment Plant residuals discharge to the county sewer system.
