**RESOLUTION APPROVING THE PROPOSAL FROM CORRECTIVE ASPHALT MATERIALS, LLC FOR THE APPLICATION OF RECLAMITE TO NORTH KREUGER ROAD AND THE STEMPLE PARKING LOT**

**WHEREAS**, the Village of Long Grove (the “**Village**”) owns and maintains various roads within the Village’s corporate boundaries; and

**WHEREAS**, the President and Board of Trustees of the Village (the “**Village Board**”) have undertaken an ongoing program to maintain and improve Village streets (the “**Road Improvement Program**”); and

**WHEREAS**, the Village Engineer has determined that reclamite, a rejuvenating agent formulated to prolong the life of asphalt pavements, can extend the lifespan of roads and parking lots by up to seven years; and

**WHEREAS**, the Village Engineer has determined that North Krueger Road and the Stemple Parking Lot are in need of maintenance; and

**WHEREAS**, in connection with the Road Improvement Program, the Village has solicited proposals for the application of reclamite to North Krueger Road and the Stemple Parking Lot (“**Reclamite Application**”); and

**WHEREAS**, the Village has received a proposal from Corrective Asphalt Materials, LLC for the Reclamite Application in the amount of \$34,143.30, attached hereto as Exhibit A (the “**Proposal**”); and

**WHEREAS**, the Village President and Village Board have determined that it is necessary and appropriate to approve the Proposal as hereinafter set forth;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS**, as follows:

**SECTION ONE. Recitals.** The foregoing recitals are incorporated herein as the findings of the Board of Trustees.

**SECTION TWO. Approval; Authorization.**

(a) The Village of Long Grove hereby approves the Proposal provided by Corrective Asphalt Materials, LLC in the amount of \$34,143.30.

(b) The Interim Village Manager, in consultation with the Village Attorney, is authorized and directed to negotiate final contract terms with Corrective Asphalt Materials, LLC in general conformity with the Proposal. Upon finalization of such contract terms, the Village President and Interim Village Manager are each authorized to execute, and the Village Clerk or a Deputy Clerk of the Village is authorized to attest, such contract and related documents (the "**Contract Documents**") on behalf of the Village; provided, however, that no person shall execute any Contract Documents on behalf of the Village unless and until the Village has received the signed Contract Documents from Heritage Technology.

**SECTION THREE. Effective Date.** This Resolution shall be in effect from and after its passage and approval in the manner provided by law.
