**AN ORDINANCE ADOPTING THE TAX LEVY FOR  
THE VILLAGE OF LONG GROVE DOWNTOWN WATER SPECIAL SERVICE AREA  
(SSA #6)**

**WHEREAS**, on September 25, 2018, the Village of Long Grove (the "***Village***") established the Village of Long Grove Downtown Water Special Service Area ("***Downtown Water SSA***") pursuant to Ordinance No. 2018-O-23 (the "***Establishing Ordinance***"); and

**WHEREAS**, the Establishing Ordinance authorizes the Village to levy and extend taxes upon real property in the Downtown Water SSA on an annual basis and pursuant to a Special Tax Roll; and

**WHEREAS**, consistent with the terms of the Establishing Ordinance, the President and Board of Trustees have determined that it is necessary, appropriate, and in the best interests of the Village and its residents to levy and extend taxes upon real property in the Downtown Water SSA, as set forth in this Ordinance;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Long Grove, County of Lake, State of Illinois, as follows:

**SECTION ONE:**      **Recitals.** The foregoing recitals are incorporated into this Ordinance as findings of the President and Board of Trustees.

**SECTION TWO:**      **Tax Levy.**

(a) Pursuant to the Establishing Ordinance, the Village of Long Grove hereby levies \$26,636.00 in SSA Taxes (as defined in the Establishing Ordinance) for the fiscal year beginning May 1, 2023 and ending April 30, 2024, against the real property within the Downtown Water SSA in accordance with the chart attached to this Ordinance as Exhibit A. In the event that such levy is found to exceed any limitation on the Village's authority to levy taxes against the real property within the Downtown Water SSA, then the levy shall be deemed to be for the maximum amount permitted by law and modified accordingly.

(b) **Abatement.** In recognition of the prepayment of SSA taxes by certain parcels within the

Downtown Water SSA, the Village hereby abates further levies against those prepaying parcels, so that the actual amounts to be levied against the parcels within the Downtown Water SSA shall be as set forth in Exhibit A.

**SECTION THREE:** **Filing.** The Village Clerk is hereby authorized and directed to file a certified copy of this Ordinance with the Lake County Clerk on or before December 26, 2023.

**SECTION FOUR:** **Effective Date.** This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form in the manner provided by law.
