**RESOLUTION APPROVING THE AWARD OF THE 2024 ROAD  
MAINTENANCE CONTRACT TO BUILDERS PAVING, LLC  
FOR BASE BID AND BID ALTERNATE**

**WHEREAS**, the Village of Long Grove (the "**Village**") owns and maintains various roads within the Village's corporate boundaries; and

**WHEREAS**, the President and Board of Trustees of the Village (the "**Village Board**") have undertaken an ongoing program to maintain and improve Village streets (the "**Road Improvement Program**"); and

**WHEREAS**, in conjunction with the Village of Kildeer and Ela Township, the Village undertook a joint public bidding process to seek bids on work to be completed as part of the Village's 2024 Road Improvement Program (the "**Joint Bidding**"); and

**WHEREAS**, based on the bids received, the Village Engineer has Builders Paving, LLC. as the low bidder (the "**Recommended Bidder**") to complete the 2024 Road Improvement Program (base bid and bid alternate) to include resurfacing Manassas Lane (Schaeffer to west end), Port Clinton Road (Forest Glen to east end), Estate Lane, Lakeridge Court, Lakeridge Drive, Sumter Drive and Sumter Court, at a total amount of \$705,777.68 (the "**Recommended Bid**"); and

**WHEREAS**, the Recommended Bidder is also the low bidder for the overall Joint Bidding (base bid and alternate); and

**WHEREAS**, the Village Board has found that the Recommended Bid of the Recommended Bidder is the lowest responsive and responsible bid for the Village's 2024 Road Improvement Program and has determined that it is in the best interests of the Village and its residents (a) to approve the Recommended Bid (as attached hereto as Exhibit A) from the Recommended Bidder and (b) to authorize a contract with the Recommended Bidder consistent with the Recommended Bid, subject to the terms of this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LONG GROVE, LAKE COUNTY, ILLINOIS, as follows:

**SECTION ONE. Recitals.** The foregoing recitals are incorporated herein as the findings of the Board of Trustees.

**SECTION TWO. Award; Authorization.** The Village of Long Grove hereby accepts the Recommended Bid and authorizes the award of a contract in the amount not to exceed amount of \$705,777.68 to the Recommended Bidder pursuant to the Recommended Bid (the "**Contract**"). The final Contract shall be in a form consistent with the bidding documents and acceptable to the Village Manager in consultation with the Village Attorney and Village Engineer, and it shall be conditioned upon the receipt of all contractually-required documentation and such other additional information as may be requested by the Village Manager in accordance with the Contract, all in a form acceptable to the Village. The Village President and Village Manager are each authorized to execute, and the Village Clerk or a Deputy Clerk of the Village is authorized to attest, the final Contract and related documents on behalf of the Village.

**SECTION THREE. Effective Date.** This Resolution shall be in effect from and after its passage and approval in the manner provided by law.
